Hello Everyone,
There have been a few conversations re: the completion of the School Valuation Reports that I want to share with everyone.

Section 1.10 Question #5 asks about average bus time for students - **this has not been provided by the Consortium as of yet - leave blank.**

Section 2.6 Questions #7 & 8 asks what is the projected utilization of your school in 5 years and 10 years - **this will require you to divide the projected enrolment (Index #10) for 2012/13 & 2017/18 by the OTG (Index 12).**

An example of this would be if the enrolment #'s were 279 in 2012/13 and 292 in 2017/18, with an OTG of 368, you would have 75.8% and 79.3% utilization respectively ($279/368=75.8\%$ & $292/368=79.3\%$).

Hope this helps.
